## Quarterly Report of Surface Mineral Substances Extraction (Consolidated Materials and Peat Moss)

Here is the procedure for the submission of a quarterly report of surface mineral substances extraction (consolidated materials and peat moss) in GESTIM.

To make the payment, the user can :

- Use a credit card

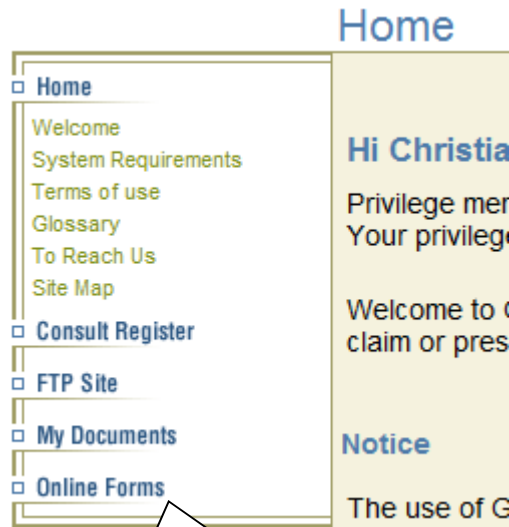

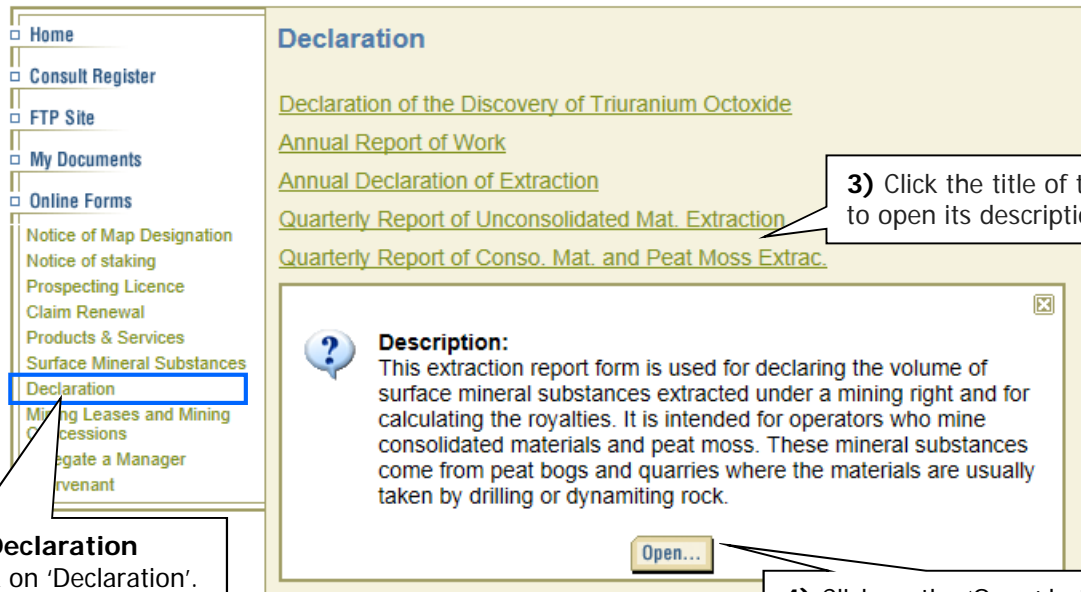
