INDEXATION OF RIGHTS, RENTALS AND FEES ON JANUARY 1st, 2014

Under section 83.3 of the **Financial Administration Act** (chapter A-6.001), these fees are indexed automatically every year on January 1st to reflect the annual change in the Consumer Price Index for Québec. The indexation factor for this year is set at 0.97%*. In accordance with section 83.6 of the Financial Administration Act, the Minister of Natural Resources hereby publishes the 2014 indexation for fees set under the Regulation respecting mineral substances, other than petroleum, natural gas and brine (chapter M-13.1, r. 2).

Accordingly, effective January 1st, 2014, the indexed fees are those listed below.
